About the Class: Open to Law Enforcement, Prosecutors, and Victim/Witness Advocates. This seminar focuses on dating-related stalking, which emanates the highest risk of violence; and also focuses on mental health disorders associated with stalking cases. Topics include:

- Identifying Patterns of Stalking;
- Challenges associated with the investigation and prosecution of stalking cases;
- Offender dynamics and uncharged acts;
- Victim safety and support; and
- Recidivism and risk of future violence.

About the Trainer: Marc A. Guillory is a prosecutor for the City and County of San Francisco. After spending the last two years as San Francisco's lead Felony Stalking Prosecutor, Marc is currently assigned to the Gang Prosecution Unit, handling serious and violent gang-related cases. Marc began his career as a Deputy District Attorney for the County of San Bernardino (California) in 2002. From 2004-2006, he was the Lead Domestic Violence Prosecutor for the Central District of San Bernardino County. From 2006-2009, Marc prosecuted domestic violence and stalking-related felonies for the City and County of San Francisco. Marc also revitalized and facilitated the San Francisco District Attorney's Stalking Task Force. The Stalking Task Force is a cadre of representatives from government and community-based organizations, whose goal is to coalesce on the development of best practices for serving victims of stalking, in response to and prosecution of criminal stalking activity in San Francisco. Marc has been a faculty member on the prosecution of Domestic Violence for the National District Attorneys Association/American Prosecutors Research Institute at the *National Institute on the Prosecution of Domestic Violence*, keynote speaker for the November 2008 *National Intimate Partner Stalking Conference*, in Chicago, IL, was a participant in a USDOJ Office on Violence Against Women roundtable discussion, "*When Battered Women Are Charged With Crimes: How Should Prosecutors Respond?*" and a presenter at the *2009 National Institute of Justice Conference* in Washington, D.C., and the *2009 Battered Women's Justice Project/DOJ-OVW National Conference*, as well as various local law enforcement agencies, victim service organizations, and anti-family violence forums. Marc is a Class of 2000 graduate of Pepperdine University School of Law, Malibu, California.
